NOTIFICATION

In exercise of the power conferred by sub-section (ii) of Section 52 of the Maharaja Bir Bikram University Act, 2015 (Tripura Act No.6 of 2015), I, Satyadeo Poddar, the Vice-Chancellor of the Maharaja Bir Bikram University, hereby notify the Maharaja Bir Bikram University First Regulations, 2018 (Third Amendment) with the approval of the Honourable Chancellor, Maharaja Bir Bikram University as under and has brought into force from May 22, 2023:

CHAPTER-VI

PH.D. REGULATIONS, 2020

104.14 as corresponding serial No. after 104.13:

104.14 Student Registration: After completion of the Ph.D. admission, every student needs to register through the student registration process. As like Undergraduate and Postgraduate students a seven-digit number in the prescribed format YYXXXXX (where YY indicates Year and XXXXX indicates number) will be allotted by the University to the students as a student registration number.

If any student already registered in MBB University in some courses and having registration number and migration certificate not been issued for the student, new student registration is not required for those students and the students only submit the application with previous registration certificate (self-attested) and the same registration number will be continued for the Ph.D. course also. If any student admitted from other University, the student needs to apply for fresh new registration with submission of Migration Certificate from that University. Accordingly, the Controller of Examinations will issue the Registration.

106.18.14 as corresponding serial No. after 106.18.13:

106.18.14 Ph.D. Title Registration:

After completion of the course work and approval of the Board of Post Graduate Studies, every Ph.D. student has to apply for the Ph.D. Title Registration in prescribed format. Accordingly, the Controller of Examinations will allot the Ph.D. Title Registration number in the format given in the Notification No.F.15(26)/MBBU/Academic/Ph.D. Regulations/2020/1061-69 dated August 12, 2022 for all the students admitted for Ph.D. course.

The other Regulations laid down in the Ph.D. Regulations, 2020 under First Regulations, 2018 (First Amendment) of MBB University may remain unchanged. All the amendments will be applicable with immediate effect.

124. General Rules:

- (2) Attendance in the Notified Seminars/ Lectures and in extracurricular activities and practical training shall be given weightage to maximum of six periods if the duration of such programme is one day and three periods if the duration of such programme is half a day. The teachers-in-charge of any such programme shall forward the attendance and other relevant papers to the Principal for reference and records. The student having less than stipulated attendance shall be declared as "Dis-collegiate". The "Dis-collegiate" candidate may be permitted to take readmission in the respective class except in case of First Semester.
- (3) In case a student fails to attend classes for one full month at a stretch from the date of commencement of classes or in any occasion during a session in any semester (except during vacation or any sufficient reason with prior permission), his / her name shall be stuck off from the rolls or register. In exceptional cases on some valid / bona fide grounds the college authority may condone such absence. If name struck off from the register, such student may take admission in the semester afresh in next academic year except in case of First Semester.
- (6) If any student found adopting any kind of unfair means/ unfair act in the examination, he/she will be debarred only from that particular examination of that semester concerned instead of debarring from rest of the examinations of that semester. The Principal shall inform the matter in details to the University. The Controller of Examinations shall refer the matter to the Disciplinary Committee of the University for final decision.

The other Regulations laid down in the First Regulations, 2018 of the MBB University may remain unchanged. All the amendments will be applicable from the <u>Academic Year 2022-2023</u> and with immediate effect.
