## NOTIFICATION

In exercise of the power conferred by the provision of Section 29 read with Section 53 and Section 58 of the Maharaja Bir Bikram University Act, 2015 and in accordance with the UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education, 2018 issued on July 18, 2018 and their amendments from time to time and communication of the UGC vide letter No.F.No.28-2/2018(PS/MHRD) dated January 02, 2019, New Recruitment Policy of Government of Tripura issued vide Notification No.F.20(1)-GA(P&T)/18 dated 05.06.2018 and letter vide No.F.2(450-114)DHE/2016/347 dated 27.01.2021 of Directorate of Higher Education, Government of Tripura, the Maharaja Bir Bikram University Council hereby makes the following rules regulating the method of recruitment and the conditions of the service to the posts of Assistant Professor in English of M.B.B University, Tripura namely:

- 1. Short title and date of commencement:
- (a) These rules may be called Recruitment Rules for Assistant Professor in English of Maharaja Bir Bikram University Rules, 2024.
- (b) They shall come into force on the date of their issuance.
- 2. The name of the post(s) shall be specified in Column-1 of the Schedule.
- Number, Classification and Scale of Pay:
   The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Columns-2 to 4 of the Schedule annexed hereto.
- 4. Method of recruitment, age limit, qualification etc.: The method of recruitment to the said post, age limit, qualifications and other matters relating to the said post shall be as specified in columns-5 to 14 of the said Schedule.
- Disqualification: No person -
  - (a) Who has entered into or contracted a marriage with a person having spouse living, or
  - (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post:-Provided that the University may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
- 6. Repeal and Saving:
  - (a) Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes,

Ex-Servicemen and other special categories of persons in accordance with the orders issued by State Government from time to time in this regard.

- (b) The existing Rules 2018 for the Post of Assistant Professor in English framed vide Notification No.F.2(4)/MBBU/ESTT/RR(TS)/17/1998-2002 dated 19.04.2018 is hereby repealed.
- (e) Notwithstanding such repeal of the existing rules, any acts done or purported to have been done under such repealed rules shall be valid and shall be deemed to have done under the corresponding rules of these rules.

SELECTION PROCEDURE FOR THE POST OF ASSISTANT PROFESSOR IN MBB UNIVERSITY AS PER UGC REGULATIONS, 2018 AND IN LINE WITH THE LETTER VIDE NO.F.2(450-114)DHE/2016/347 DATED 27.01.2021 OF DIRECTORATE OF HIGHER EDUCATION, GOVERNMENT OF TRIPURA.

- The overall selection procedure shall incorporate transparent, objective and credible methodology of analysis of the merits and credentials of the applicants based on the weightage given to the performance of the different relevant parameters and his/her performance on a grading system proforma, based on Appendix II, Table: 3A of the UGC Regulations, 2018 as amended.
- The Academic score as specified in Appendix II, Table: 3A for Universities, shall be considered for short-listing of the candidates (Maximum 5 candidates for each post notified) for Interview.
- MBR University shall constitute Selection Committee and fix qualifying cut off mark (if any) for interview as per UGC Regulations, 2018 as amended time to time.
- 4.
