# **1. EXECUTIVE SUMMARY**

# **1.1 INTRODUCTION**

Since its inception in 2015, MBB University has taken initiatives to improve the fields of teaching, learning and research. It is acting as an acknowledged learning destination by imparting quality education to the students of Tripura and other part of this region. The scenic beauty of the University campus located in midst of natural ecosystem of College Tilla provides a good academic atmosphere for teaching and learning. Tripura is rich in indigenous art & culture and traditional practices which are a matter of immense pride in the region and great asset for the country. MBB University has taken a special attention to preserve, maintain and flourish this rich cultural heritage. The University is providing educational support to the aspiring youths and extending its cooperation to the unemployed and the socio-economically deprived section of the state. At present, there are five Post Graduate Departments and two Integrated Master's Degree Program in Chemistry and Commerce. Besides, the University also has academic programs like Bachelor of Library and Information Science, Post Graduate Diploma in Library Automation, Diploma in Goods and Services Tax. It also offers PhD program in Mathematics, Political Science, Library and Information Science and English. The future plans of the University include expansion of the academic departments and physical infrastructure with installation of ICT enabled classrooms in all the academic departments. The University is ready to provide improved canteen facilities and to maintain a guest house. MBB University is also gradually transforming to a paperless administration through e-governance initiatives to every sector making it more eco-friendly and efficient system in terms of delivery of services. The University has already introduced online mechanism in admission & examination process, collects online feedback from the stake holders to make the process more convenient and friendly to the students. ## **1.3 CRITERIA WISE SUMMARY**

#### **Curricular Aspects**

The curricula of the University are framed and designed to explore the local resource of the region and fulfil the objectives of the University through ideas, imaginations and innovations. The University aims to create good human beings and responsible citizens, generate employability and expand the boundary of knowledge through proper education and research activities associated with current trends of academia. It also seeks the development of the scheduled tribes and scheduled caste community of Tripura by protecting and preserving their traditional knowledge system and cultural contour of the state. The students are inspired to remain connected with the latest global trends and development in the field of knowledge and research. Syllabus revision takes place periodically for academic augmentation. Introduction of new programmes is an indicator of gradual academic progression. The University started its academic journey with four academic programmes in 2016-2017. Now it offers five academic programmes and two Integrated Master's Degree programmes with focus on employability and skill enhancement to increase the prospects of the graduates employable in the job market. The offered programmes operate under the CBCS framework. Gender sensitivity and gender sensitization is given special attention. The University offers courses like Women's Writing, Feminism etc. in the curriculum of PG course in the Department of English and Political Science. NSS Unit organizes International Women's Day involving the NSS volunteers and students. The students are encouraged to promote the gender sensitivity and the curricula have been framed along with the gender neutral character of the region. The curricula also draw special attention on the cultural diversities of the region, environmental ecosystem and pursue the goals of sustainable development. The MBB University follows Policy Guidelines for prevention of Ragging, Plagiarism and Harassment etc.to maintain professional ethics and human values in the academic as well as administrative work fields. Emphasis has been made to incorporate value-added courses for enhancing life skills in the academic programmes. Students have undertaken projects and internships. The students participate in different outreach programmes such as quiz, drama, extempore competition etc. and visit & perform community engagement activities like anti-drug, environmental awareness programme in the adopted village - Dighaliya Gram Panchyet.

#### **Teaching-learning and Evaluation**

MBB University is a home of large number of students from the socially weaker sections of Tripura. It caters the need of pursuing higher education for those students who are economically disadvantaged and do not have the opportunity and resources to go outside the state for education purposes. The admission to various programmes is conducted through advertisement published in local dailies and University website. From the academic 2023-2024, the University follows CUET conducted by National Testing Agency to admit eligible students to various PG programmes. Tutorials are conducted and personalized teaching method is employed to reach out the weaker students. Soft skill course like compulsory open elective in computer is offered to the students to enhance their soft skill ability. Besides, Communication Skills in English is a compulsory open elective course to improve their written and spoken skills in English. The NSS cell also offers one open elective course in NSS to inculcate the feeling of patriotism and universal brotherhood. Teachers employ both traditional and modern teaching methods. Pedagogical practices include use of skill labs, case studies, class based seminars, presentations, laboratory-based learning for science courses; use of ICT based methods; projectbased training/field studies; ICT enabled class rooms to suit practical and participatory methods of teaching. There are adequate number of textbooks, reference and e-journals in the library. The University is practising Mentor-Mentee mechanism for overall development of the students in their career choice, professional ethics and psychological issues. The internet facilities are available in both the academic and administrative buildings. Remedial measures for slow learners are adopted to support weak students. The Choice Based Credit System provides the freedom to the students in course selection. Continuous evaluation of students performance is assessed through written examinations, internal assessments and assignments, class seminars, providing them the opportunity to improve themselves. The process of student admission and fee payments is conducted online/offline for facilitating the students to access information even from remote areas and get admitted in a hassle-free environment. All these efforts are contributing University to be an attractive place of learning, teaching and research in the region.

#### **Research, Innovations and Extension**

The MBB University is committed to excel in research, innovation and extension to contribute in Nation Building. The University has a Research and Consultancy Policy and Intellectual Property Right (IPR) Cell to promote research and extend external consultancy to both private and public organizations. The University is involved in developing ideas through collaboration with other established institutions such as Navanalanda Mahavihara, Bihar, Central Sanskrit University, New Delhi, Research for Research Foundation, Nagpur and University of Science and Technology, Meghalaya. The four academic departments offer PhD programmes and now there are seventeen number of research scholars. The faculty members are involved in various research activities besides supervising PhD scholars.

Out of eight number of pass out students, seven are pursuing PhD work in MBB University and one in Tripura University. Twelve students of the Department of Mathematics have participated in Research Project Competitions organized by Tripura State Council for Science and Technology and two of them were awarded. Two numbers of students from Mathematics Department were selected to present their project in the Student Research Convention organized by Association of Indian Universities at Jadavpur University. A good number

of peer reviewed publications are there having in both UGC Care List and Scopus index journals. A total of eight numbers of books are now to the credit of the faculty members and they contributed many chapters in edited volumes. The departments also have successfully organized seminars, conferences and workshops to contribute knowledge to the newly emergent fields. The PhD scholars have some publications in reputed journals. The University promotes regular engagement of faculty, students and employees with neighbourhood community for fostering social responsibility and sensitization. Community-based programs like awareness programs against HIV/AIDS, injecting drug use, plastic pollution, workshops, rallies, blood donation, cloth donation, tree plantation, gender sensitization, female feticide, road safety etc. have been organized in order to aware and sensitize the students to social issues and holistic development.

#### **Infrastructure and Learning Resources**

The University has twin buildings - Administrative Building and Academic Building. Over the years, efforts have been made to improve the physical ambience by renovation and purchasing adequate equipment for classrooms, smart class room, seminar halls and faculty rooms. The University library has a collection of about eleven thousand volumes belonging to different disciplines. Library automation is introduced for digitalization of the library. There are adequate number of tables and chairs for reading-learning in the library. A photocopier has been installed for photocopying various documents. There are sufficient number of class rooms. Both buildings are equipped with ramp and lift facilities for the physically challenged students. There are separate toilets both for male and female students on each floor. The RO filter is available for drinking water. The MBB University has a central computer lab consisting with enough number of desktops. . Various sports equipments such as Cricket Bats, Balls, Wickets; Footballs; Badminton Bats-Feathers etc. are available and sports events are organized. The University promotes socio-cultural values among the students for preserving diverse cultural values and heritages of Tripura as well as India. The various clubs, centres and cells organize different programmes for sustaining a healthy academic environment within the campus. The whole campus is under CCTV surveillance with 24 x 7 physical security available inside the campus. Fire Extinguishers have been installed in all each floor. The University follows an established systems and procedures for maintaining and utilising physical infrastructures etc.by authorized agencies. The University follows the General Financial Rules (GFR) of the Department of Finance, Government of Tripura for purchasing equipments and other accessories. The University issues tenders, quotations as per requirements and purchases different items from Government e-Market (GeM) as per provision. The financial transactions of the University are audited annually by the External Audit Firm engaged through open tender. Audit is conducted regularly by the C & AG, Government of India. To make the admission and examination process hassle-free and making it students friendly, the University has introduced Online System including making payment

#### **Student Support and Progression**

MBB University has been working to enhance and promote the quality of human resources among the students. Over the years, several steps have been taken and executed to provide quality services to the students. Some of them involved in providing direct support and assistance to the students include Equal Opportunity Cell, student exchange programmes, Internal Complaint Committee (Prevention, Prohibition and Redressal of Sexual harassment), Placement Cell, Students Services Centre, Grievance Redressal Cell etc. These cells/committees have been supporting to enhance psychosomatic development among the students. The Students Services Centre in collaboration with IQAC organized an awareness programme on "Prevention of depression and suicide among students" on 28th August, 2023. The University introduced a NET coaching cetre to provide coaching to the students. The faculty members always motivate the students to build their career prospects. The

students always extend co-operation for the development of the University by participating in curricular and cocurricular activities and providing views through feedback forms. Alumni students of the University take active part in cultural and social activities and furnish their views for the development of the University through feedback. International Yoga Day is celebrated every year with demonstration of Yoga and meditation for maintaining and promoting good health & sound mind. The stipend section of the University coordinates with the academic departments to apply for various scholarship schemes offered by the Central and State government. Career counselling cell organizes seminars and discussion session to create awareness among the students about employment opportunities available at public and private sectors. The cell also provides mentorship and career counselling guidance to benefit students' for securing placements. MBB University also offers soft skills, language and communication skills courses for enhancing the employability skills and prospects among the students. Students are encouraged to enroll themselves in NSS and participate in various community engagement activities, sports and cultural activities to build their career in various fields at different levels.

#### **Governance, Leadership and Management**

The University has qualified, able and competent administrators to provide effective leadership and management at various levels. The Leadership ensures the compliance of academic and administrative processes and procedures along with the continual improvement through regular systematic audits, checks and monitoring by well-defined Quality Assurance Framework. Though there are administrative hierarchies, the academic departments enjoy autonomous functioning through the process of administrative decentralization. The University administration at various levels is always open to suggestions for taking decisions for the benefits of the stakeholders. The University administration ensures that teaching, learning, research and office administration perform their activities and responsibilities in accordance with various statutory bodies like the MBB University Council, the Academic Council, the College Development Council, the Board of Post Graduate Studies, the Board of Under Graduate Studies and the Purchase Committee. Annual Performance Appraisal Reports for teaching staff are regularly maintained. The Internal Quality Assurance Cell (IQAC) regularly conducts meetings to build and ensure quality culture at the institutional level. The IQAC organizes different programmes with active participation of faculty members and students in order to ensure faculty empowerment and benefit the students. The feedback process is very important for optimal and efficient utilization of all the resources. This also marks the standard and requirement of up gradation in academic and administrative process. Regular feed backs on teaching-learning mechanism, administrative aspects, developmental aspects etc. are collected from the major stakeholders. The University maintains transparency in financial management, resource mobilization and optimum utilization through the active assistance and monitoring of the Purchase. The University engages one external audit farm for financial audit in each financial year. Grants received from external funding agencies/organizations by faculty members are also subjected to audit for maintaining transparency and submitting the utilization certificate. Academic and administrative audits are conducted to ensure quality and progress in academic and administrative departments. To sum up, MBB University is ever alert and proactive in governance, leadership and management both at the macro and micro levels of operation. Besides, MBB University has conducted Green and Gender Audit under the supervision of IQAC aiming for all round development of the University.

#### **Institutional Values and Best Practices**

Located in the midst of natural beauty with rich cultural, historical and ethnic diversities, MBB University endeavours to promote environmental sustainability and enrich the socio-cultural fabric of Tripura through several extensive outreach programs. MBB University has adopted *Swachhta Hi Seva: A Green Initiative* as one of its best practices with objectives to create an environment friendly campus, to generate awareness about environmental sensitivity among the students and local communities, to maintain biodiversity and ecological balance in the University campus etc. As a part of it, instead of plastic covered flower bouquets, University has adopted the practice of felicitating the dignitaries with tree saplings and the University campus has been declared plastic free and tobacco free campus.

Another best practice of the University is the *Enhancement of the extracurricular and research temperament of the students* with the objectives to inculcate a healthy competitive mind-set among the students, to inculcate the research temperament among the students, to generate innovative and creative thinking among the students, to sensitize the students about the rich cultural legacy etc. As a part of it, the University regularly organizes various cultural programs involving the students, organizes Quiz, Debate, Extempore, Speech, Poster Making Competitions etc. on regular basis to generate healthy competitive temper among the students and the students are encouraged, motivated and guided to participate in various research competitions within and outside the University.

The University performs various community development activities in the adopted village and surrounding locality through NSS unit for fostering social responsibility and community engagement. In Northeast region of India including Tripura HIV/AIDS prevalence is very high. The NSS unit and Red Ribbon club organize Awareness Programme against HIV/AIDS Epidemic and Injecting Drug Use (IDU), Rally against HIV/AIDS and Injecting Drug Use. The University follows the ideology of Swami Vivekananda who said to serve the others is to worship the God. The University extends its helping hand towards helpless by organizing relief camps for people in distress, cloth, eye and blood donation camps, providing donations in relief funds etc.

Multidisciplinary/interdisciplinary:	The MBB University always encourages multidisciplinary and interdisciplinary concepts in its academic curriculum as well as in research area in the light of the spirit of National Education Policy (NEP) 2020. The University already adopted the principles of NEP 2020. It has already been implemented in
	under graduate level to encourage the multidisciplinary studies in its academic curriculum.

	Each of the PG department of the University offers an open elective course for the students of other departments to spread the interdisciplinary curriculum. The Department of Mathematics offers Mathematics for Social Science as an open elective course for the students of other departments. In the same way, Department of Political Science, English, History, and Library & Information Science offer Indian Constitution and Institutions, Popular Fiction, M. K. Gandhi & India, Basic of E-Resources & Open Access as open elective course for the students of other departments respectively. Besides, Communication Skills in English and Basic Computer Skills are offered as compulsory open elective courses for all students. Moreover, NSS is also offered as an open Elective Course for the interested students of all Departments. There are some courses like Environment and Disaster Management of the Department of History, Mathematical Biology, Operations Research, and Project Work offered by the Mathematics, Micro and Macro-Economics, Business & Commercial Law, Business Mathematics & Statistics, Income Tax, Law & Practice of Integrated Master Degree (IMD) in Commerce, Feticide Chemistry, Clinical Bio-Chemistry, Pharmaceutical Chemistry, Environmental Chemistry etc. of IMD in Chemistry are interdisciplinary in nature.
2. Academic bank of credits (ABC):	MBB University has already accepted NEP 2020 and implemented curriculum designed as per guidelines of NEP 2020 at under graduate level in its affiliated colleges from the academic session 2023-24. One of the important aspects of NEP 2020 is the concept of introducing Academic Bank Credits (ABC) for greater academic flexibility. According to this ABC system, credits awarded to a student for one programme from an institution may be transferred by another institution upon the consent of the student. Accordingly, MBB University has issued a notification on October 12, 2023 requesting the students to submit their relevant documents for registering with ABC. A good number of students have already registered with ABC.
3. Skill development:	MBB University envisions advancement and dissemination of knowledge among the students along with skill enhancement to make them

	employable. The University focuses on introducing skill based courses while framing and revising the syllabi of different academic departments. There are courses such as Communication Skills in English, Basic Computer, NSS, Project/Dissertation; Environmental studies etc have designed for skill and ability enhancement. The University offers Goods and Services Tax (GST) as Diploma course to enable the students to make them self-sufficient, and Post Graduate Diploma in Library Automation and Net Working to improve the skills of the students using library through online mode.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	MBB University has taken the initiative of integration of Indian Knowledge System (IKS) by incorporating a course on IKS. Department-wise IKS courses are given below: Name of the Department: Mathematics Name of the Course: Vedic Mathematics Name of the Department: History Name of the Course: Indian Knowledge System Name of the Department: Political Science Name of the Course: Traditions of Knowledge System in Ancient Indian Polity Name of the Department: English Name of the Course: Indian Aesthetics: Theories & Comparison Name of the Department: Library & Information Sciences Name of the Course: Ancient Library System India. There is provision for opting courses from SWAYAM. Accordingly, students of MBB University can choose a course from SWAYAM in the Second Semester instead the courses offered by the academic departments. As per requirement of the students and situation, the academic departments conducted online classes.
5. Focus on Outcome based education (OBE):	Various courses offered by different academic departments of MBB University have been designed with well-articulated ideas with clarity in objectives for the purpose of continuous evaluation of the students to understand their progress. Each course has course specific outcome with clear expectation of what the students will learn by the end of the course. They are expected to improve analytical ability, problem solving skill, skill in creative expression and thus they are able to demonstrate when they exit from the University. For the purpose, the feedback mechanism is followed. Accordingly course wise feedbacks from the students, Alumnus, guardians are taken to address shortcomings, if any, and seeking opinion for the development of University.

6. Distance education/online education:	The University does not offer education under distance mode. However, as per requirement, some classes are conducted through online inviting prominent Professors. During Covid-19 situation, classes, seminars and conferences were conducted through online mode. Presently, seminars, conferences and programs are organized through blended mode.

Maharaja Bir Bikram University was established in November 01, 2015 by the Government of Tripura through the Maharaja Bir Bikram University Act 2015. The primal PO of the University is to pursue a journey from academic knowledge to wisdom of life through ideas, imaginations and innovations. It aims to create good human beings and responsible citizens, generate employability and expand the boundary of knowledge through proper education and research activities associated with current trends of academia. Another PO is the development of the scheduled tribes and scheduled caste communities of Tripura by protecting and preserving their traditional knowledge system and cultural contour of the state.

• The POs of the Department of Library & Information Science is to provide theoretical and

This department offers courses like Mathematical Biology, Mathematics for Social Sciences, Operations Research, Project Work which have COs in coherence with the interdisciplinary aspects of NEP 2020.
- The Post Graduate Diploma in Library Automation & Networking course is offered by the Department of Library and Information Science to provide a practical knowledge on Library Automation and Net Working.
- The GST course provides a practical knowledge to the students to make self-sufficient for meeting the spirit of AATMA NIRBHAR BHARAT.
- The POs of Integrated Master's Degree in Chemistry and Commerce are to develop the research acumen among the students along with subject specific knowledge.
- The PO of History is to impart knowledge which will link students from past to present for meeting the future challenges. The CO is directly link to Indian knowledge system in advancing research during ancient, medieval, modern and contemporary periods.
- The NSS unit of the University offers a course with COs dedicated to theoretical and practical application towards youth development, community & social services, environmental issues, yoga & meditation.
- University also provides option to the students to opt courses from SWAYAM portal with credit flexibility to meet DIGITAL INDIA mission and NEP 2020.

### 1.1.2

The Programmes offered by the institution focus on employability/ entrepreneurship/ skill development and their course syllabi are adequately revised to incorporate contemporary requirements

#### **Response:**

The University started its academic journey in 2016-2017. The main focus of the University is to pursue academic knowledge through ideas, imaginations and innovations as well as to make good human beings and responsible citizens, generate employability.

The courses like Abstract Algebra, Linear Algebra Real Analysis and Measur Theory, Ordinary and Partial Differential Equations, Numerical Analysis, Topology etc. are prepared in the spirit of syllabi for NET in Mathematical Sciences and some other competitive examinations. The department also offers

Operations Research, Nonlinear Dynamics, Project Work etc. to eenhance modelling skills of the real world problems, presentation skills etc.

The courses such as Political Theory, Indian Constitution, Public Administration, International Relations, Indian Political Thought, Environmental & Disaster Management of Political Science and History of English Literature (Chaucer to Milton), Poetry-I, Drama-I (Elizabethan and Jacobean), Literary theory and Criticism –I are useful for taking preparation for different competitive examinations conducted by UPSC and SPSC.

The courses of History such as Post Independent India, M. K. Gandhi and India, Contemporary Europe (1945-1991), Socio-Economic History of Northeast India and Indian Nationalism offer scope for taking preparation for civil service and other competitive examinations.

Inorganic Chemistry-I-VIII, Environmental Chemistry, Basic Statistics and Computer Skills, Super molecular and Nano Chemistry, Medicinal Chemistry and Forensic Science offer opportunity to be employed as Chemist, junior scientist, Assistant Professor, forensic scientist, biomedical scientist, toxicologist, medicinal chemists, biopharmaceutical and biotech industries etc. Financial Accounting, Principles Management, Business Statistics, Principles of Banking of Banking, Advanced Marketing & Human Resource Management, Auditing Theory & Practice, Risk Management etc. offer the scope of employment in both private and public sectors in various capacities such as bank officer, budget coordinator, demographer, economist, research analyst, auditor etc. The courses of Library & Information Science such as Foundation of Library and Information Science, Field Work & Literature Survey, Knowledge Organization & Cataloguing, Computer Skills of Library & Information Science help candidates to be employed as Library Attendant, Library Assistant, Librarian, Library Program Coordinator, Library Technology Officer, Record Manager, Indexer, Souter, System Admin, in different public and private organizations.

Each department offers a compulsory open elective course on basic computer to develop the soft skills as well as to equip them to the computer based modern job market. Besides, Communication Skills in English is offered to improve the confidence and skills in English so that the students can prepare themselves during interview. The NSS cell offers NSS as open elective to inculcate the feeling of patriotism, universal brotherhood and skill of team spirit. The University offers Goods and Services Tax (GST) course to enable the students to make them self-sufficient, and Post Graduate Diploma in Library Automation and Net Working to improve the skills of the students using library through online mode.

For improving skills among the students, MBB University presently offers courses Communication Skills in English, Basic Computer, NSS, Project/Dissertation etc. The different academic departments pay considerable attention to widen the scope of these skill based courses during syllabi revision by incorporating the contemporary requirements.

#### **1.3 Curriculum Enrichment**

#### 1.3.1

Institution integrates cross-cutting issues relevant to Professional Ethics, Gender, Human Values, Environment and Sustainability and other value framework enshrined in Sustainable Development Goals and National Education Policy – 2020 into the Curriculum

#### **Response:**

From the inception University's curriculum and pedagogy emphasize due importance on academic as well as socio-cultural acumen of the students through practical field works and real life applications of theoretical knowledge. This process is expedited by the introduction of CBCS and other activities in the curriculum such as:

• The NSS Unit in collaboration with Red Ribbon Club, Eco Club, Yoga & Meditation Center of the University organizes Blood Donation Camp, Cloth Donation programme, Swachhata Hi Seva Mission, Independence Day, Republic Day, National Youth Day, International Women's Day,

International AIDS Day, Yoga Programs, Special Camps etc. NSS volunteers and Red Ribbon Club members regularly serve for community enrichment, skill development and socio economic benefit of the villagers Digialia Gram Panchayat, Bamutia RD Block, West Tripura, the adopted village of MBB University.

- The Science Club, Quiz Club regularly organize programs and competitions to boost the scientific temper and general knowledge of the students.
- The Music Club, Drama Club and Cultural Committee organize various cultural programs, workshops etc. to increase the social harmony, integration and team spirit. The students are encouraged to participate in extempore competition, debate competition, short film competition, student project competition, quiz competitions, gender sensitivity programs, Anti Drug and AIDS awareness campaigns, poster competitions outside and inside the University to boost their professional ethics, humane sensitivity.
- Gender sensitivity and sensitization are accomplished through amalgamation of theory and practice. University offers courses like Women's Writing, Feminism etc. in the curriculum of PG course in the Department of English and Political Science. The University has formed a Women Help Desk to address various issues and grievances related to the women students and employess. NSS Unit also organizes International Women's Day involving the NSS volunteers and students. Students are appraised through these courses, centre and other activities such as seminars, invited lectures etc. about conceptual, theoretical and analytical understanding on gender issues to work towards gender equity within India from a cross-cultural perspective.
- Human values related activities of students are being conducted since inception of the University. The Department of Political Science offers a course entitled Human Resource Administration related to human values and professional ethics.
- University follows Policy Guidelines for prevention of Ragging, Plagiarism and Harassment etc. to maintain professional ethics and human values in the academic as well as administrative work fields.
- The Department of Political Science offers a course on environmental administration and disaster management and enables students to understand about the importance of environment sustainability and the need of collective effort during natural disaster.
- Tree plantation, rally against plastic pollution, cleanliness drive, Clean India Programmes are conducted regularly. University campus has been declared as Tobacco and single use Plastic Free Campus.
- University has introduced NEP 2020 in the under graduate level from the academic session 2023-24. Each PG department offers an open elective course for the students of other departments to encourage the interdisciplinary research in the spirit of NEP 2020. Moreover, Project Work, Dissertation and some othe courses offered in PG curriculum reflect interdisciplinary aspects of NEP 2020.

### 2.2 Catering to Student Diversity

#### 2.2.1

The institution assesses the learning levels of the students and organises special Programmes to cater to differential learning needs of the student

#### **Response:**

University organizes Orientation Programme for newly admitted students in order to acquaint them about Academic Pedagogy, Social Responsibilities, Rules and Regulations of MBB University, Rights and Duties, Career related Guidance, Course Structure, Facilities Available, Attendance & Discipline etc. The University also organizes Orientation Programme regarding Library Rules, Availability of Library Resources, Library Discipline, usage of Digital Technology etc. for newly admitted students. The faculty members are dedicated to identify and assess the needs, requirements and experiences of the students for

motivating them towards various curricular, extra-curricular and scholarly works. The academic structure of the University also emphasizes on continuous evaluation of the students to determine their strength and limitations. The major issues related to the academic improvements of the students are addressed through tutorial and remedial classes. Each department reviews the semester-wise class performance, responsiveness and examination result of the students to study and analyze their academic growth. Based on this review work tutorial and remedial classes are conducted according to the needs of the students.

The University introduced one compulsory course – Communication Skills in English to minimize the language barrier in learning and overall development of the students. It also opened a Remedial Coaching Centre to look after the process of conducting remedial classes. Faculty members of each department conduct remedial classes in which extra time is given to the slow learners. Additional assignments are given to them to strengthen their concepts and understanding in a course. Faculty members regularly review academic progress and counsel students to improve performance and ensure academic growth. Based on the performance of the students in the classes as well as in the examinations, the students are categorized into two groups, namely, slow learners and advanced learners. Different pedagogy is applied for slow and advanced learners:

#### i) Slow Learners:

- 1. Organizing Extra Classes during the semester.
- 2. Giving practice assignments.
- 3. Go through the assignments and identify the areas needed for correction and improvement.
- 4. Providing extra reading materials to improve basic understanding of the subject.

#### ii) Advanced learners:

- 1. They are given additional assignments.
- 2. They are also encouraged to write and present research papers in different Departmental as well as National Seminars organized in the University.

University encourages students to participate in seminar with paper presentation, students' research project competition and participation in extempore speech, essay writing competition, quiz competition etc. organized in and outside of the University. Besides, the University has set up a Career Counseling Cell to aid, encourage and advise a student about the career prospects of each course and the Cell periodically organizes career advancement lectures from job market experts. University has also formed a Center to train the students for various state and national level competitive examinations.

#### **Response:**

MBB University has a student centric philosophy. Various methods of experiential and participatory learning are adopted to ensure that students are active participants than remaining passive listeners in the teaching-learning process.

1. The participatory learning activities adopted by the faculty members to develop an application-based outlook of the students are:

- 1. Group discussion
- 2. Presentation
- 3. Seminars, popular lectures by esteemed scholars, classroom workshops

The MBB University introduced Mentor- Mentee Cell with a vision to extend support and guidance to the students studying in the University for betterment of their academic and professional career as well as psychological development.

The students often experience various academic, psychological, and socio economic challenges. The main aim of this cell is to bridge connection between the students and the teachers, and to address such problems of the students. The main aims and objectives of this cell are as follows:

- 1. To minimize the gap between the students and teachers.
- 2. To create the environment for quality performance of the students in academics and cultural activities.
- 3. To ensure the holistic development of the students.
- 4. To provide mutual support and congenial learning environment.
- 5. To encourage and motivate for higher studies and competitive examinations.
- 6. To discuss stress and psychological related issues.
- 7. To regulate the academic involvement and assess the outcome

The concerned teacher as a Mentor provides guidance to the students through counselling, group discussion, personal attention, awareness lectures, career guidance etc. It is a fact that a significant number of students of the University exhibit the symptoms of depression and mental frustration during their course period. The reasons are often observed to be fear of unemployment, socioeconomic pressure, peer pressure etc. The mentors play a pivotal role to free the minds of the mentees from different psychological traumas and depressions through morale boosting, counselling, drug abuse etc. According to the convenience and comfort of the mentee, sometimes such counselling is conducted with the mentee in one to one mode. Moreover, if a mentee shows extreme symptoms, then his/her guardians are informed immediately so that the mentee can avail professional help. The mentors also support the mentees to prepare precise course content, arrangement of academic fees, admission process, research activity and scholarships etc.

The scheme would become very successful to decrease the communication gap between the teacher and the student. A student, who cannot share his /her issues in front of the parents, may feel comfortable to do the same, in front of the teachers. It can be a tool in blending the harmonious relationship between the learner and the University at large. It has definitely created an atmosphere of conviction and faith in the University campus. We focus that all students get rightly educated and take the right step towards building their career.

General Facilities and Classrooms: Properly functional toilets for male and female students, drinking water facility, fire extinguishers etc. are available in every floor of the Academic Building along with ramp and lift to support differently-abled students. The classes of IMD in Chemistry and Commerce are conducted in affiliated MBB College and BBM College respectively. The classes of all other programmes are conducted in the Academic Building. All the classrooms are well furnished with adequate number of desks, whiteboards, fans, lights, tables; chair etc. to intake all the students in any academic program and course. Airflow and natural light for unhindered visibility are sufficient in each classroom. The three conference/seminars halls are used for academic activities as well. There is a student Common Room where the students spare their break time by playing indoor games.
- Laboratory: A central computer laboratory with 35 desktop computers is established in the Academic Building. Computer based classes of all the departments are conducted in this laboratory. The well-equipped Chemistry and Physics laborites of MBB College are used conducting for practical classes and examinations for IMD Chemistry programme. The University provides financial assistance and up-gradation of laboratories.
- 1. The IT infrastructure is yet to be fully developed. However, the University has extended *ICT enabled facilities for teaching-learning process. It has* one ICT enabled conference hall for teaching learning process. The University Central Library has been consistently making efforts to develop a strong collection of learning resources. It has a good collection of resources taking into consideration the course contents and research needs of the several departments of the University. The Library is automated using Integrated Library Management System (ILMS) and has introduced digitization facility for betterment of the students.
- 2. University provides adequate facilities for cultural activities, yoga, sports etc. to boost up the cultural minds and healthy lifestyle of the students.

**Cultural activities:** The Cultural Committee organizes cultural events involving the students to enrich cultural talents, generate social harmony & team spirit and trains & motivates to participate in various

programs inside and outside the university. Various musical instruments such as harmonium, tabla, tambourine etc. are available. The university also inculcates the cultural talents and acumen of the students through Drama Club, Music Club, Debate Club, Quiz Club and Movie Club activities.

**Yoga and Meditation Centre:** University has formed a Yoga and Meditation Centre to encourage and train the students in yoga and meditation practices. This centre along with NSS unit organizes yoga and meditation practices in collaboration with external organizations.

**Sports Facility:** Various sports equipment such as Cricket Bats, Balls, Wickets; Footballs; Badminton Bats-Feathers etc. are available. The sports committee organizes sports event involving students to increase physical activity and team spirit. Intra University competitions in Outdoor sports such as cricket, football, tug of war, running race, relay race etc. and indoor games such as chess, carom etc. are organized.

*Gymnasium:* The students are encouraged to take part in regular gymnasium practice through organization of different programmes.

#### **Response:**

MBB University follows the best systems and procedures in maintaining and utilizing physical, academic and support facilities such as laboratory, library, sports complex, computers, classrooms, etc.

- Infrastructure and Maintenance: In terms of maintenance, the university has in-house maintenance support, annual maintenance contract/Annual Maintenance Contract given to reputed service providers and outsourced through external agencies. The university follows property insurance system maintained by a reputed insurance agency. The overall maintenance of University property, classrooms, building & construction, Electrical & Civil Works etc. is looked after by the Public Works Department (PWD) and Electrical Engineering Department, Government of Tripura. The outsourcing security personnel look after the security of the university campus. The university maintains sanitation, horticulture and green initiatives by the outsourcing cleaning and sweeping staff.
- Maintained of Clean and Green campus: The university campus is very green. There are two lakes surrounding the university campus. The university invests for maintaining its horticulture, gardening and greenery. University buildings, rooms and toilets are cleaned on daily basis by the dedicated cleaning and sweeping staff. The campus of the University is cleaned on a regular interval by the NSS volunteers. There are dustbins at every corner and corridors which are emptied regularly. Wastes generated inside the campus are effectively managed with Agartala Municipal Corporation (AMC) for its disposal.
- **Safety Measures:** The whole campus is under CCTV surveillance with 24 x 7 physical security available inside the campus. Fire Extinguishers have been installed in all areas maintained by University and periodically serviced by authorized agencies.
- **Financial Manual**: The University follows the General Financial Rules (GFR) of the Department of Finance, Government of Tripura for purchasing equipments and other accessories. The University has a dedicated purchase committee to purchase different items for the university. The university issues tenders, quotations as per requirements. The university also purchases different items from Government e-Market (GeM) as per provision. The financial transactions of the University are audited annually by the External Audit Firm engaged through open tender. A dedicated committee takes into physical verification of the assets of the University for Stock maintaining. In addition to this, audit is conducted regularly by the C & AG, Government of India. The university follows proper taxation procedures on all financial transactions.
- Store Section: The University has a well-established store section for providing support related stationary and other items required for different departments/sections/branches of the University.
- Maintenance of Computers: The University engaged a farm through tender for Annual Maintenance Contract (AMC) of computers of the University. The farm regularly monitors to make maintenance of the computers of laboratory, library, office etc.

# Efforts taken by the institution to provide career counselling including e-counselling and guidance for competitive examinations during the last five years

### **Response:**

The University has a dedicated Career Counseling and Placement Cell for counseling and guiding the students to equip them with proper knowledge. The cell conducts activities like vocational and training programmes/workshops/ Webinars/Seminars with the aim of empowering students to make informed decisions about their future and various competitive examinations and job opportunities. The topics of these programmes include resume building, interview skills, professional communication skills, reasoning and recent trends which provide valuable insights and knowledge to prepare them for

competitive job market.

A webinar on "Career Counseling and Guidance" was held On 21st August 2021 wherein Dr. D.K Verma, State Counsellor, Lucknow, Uttar Pradesh and Shubhra Dinesh, Delivery Lead at Manpower Group, Gurgaon delivered lectures as the resource person. The aim of the webinar was to encourage the students to venture for career opportunities in the corporate world and to provide knowledge about the necessary skills, resume and interview preparation. Another webinar on "Developing Employability Skills- Career prospects in Armed Forces" was organized on August 17, 2022 in collaboration with Poshac India Foundation, New Delhi with an aim of providing information about opportunities and scope in the military services. The cell also addresses the needs of the weaker section of the society and organized a Two Day workshop on "Job Opportunity and Employability prospects for S.T youths of Tripura in collaboration with the Tribal Research and Cultural Institute, Government of Tripura on September 29-30, 2022 to provide guidance about preparing for competitive examinations and its procedures and to encourage the youths to venture into entrepreneurship. It also organised awareness programme about UPSC and SSC examinations on August 10, 2023. A Vocational Guidance Training Programme is also being organized in collaboration with the District Employment Exchange, Government of Tripura from November 26, 2023 in order to boost up confidence and train the students with the necessary skills required for various job interviews. The cell also circulates the necessary employment news and advertisement through a Whatsapp group.

The Cell attempts to address the needs of the alumni by offering career counseling services and providing other resources to alumni to navigate career transitions and stay well informed about recent developments. Overall, the University Career Counseling and Placement Cell is a dynamic hub that goes beyond traditional academic guidance and works as a catalyst for empowering students to navigate their career choices by equipping them with necessary skills and knowledge for success in their chosen fields.

The Anti-Ragging Committee of MBB University is comprised of student representative (senior & fresher) in compliance with the UGC Regulations on Curbing the Menace of Ragging in Higher Education Institutions, 2009 under clause 6.3(a). The Sports Board organizes sport events in consultation with students representing as member in the Committee. The Internal Complaints Committee (ICC) of the MBB University consists of student to look after any redressal of sexual harassment in the Workplace as per Vishaka Guidelines. The Internal Quality Assurance Cell (IQAC) of the MBB University also has a student representative. The Red

## 6.1.1

#### **Response:**

The governance of the University is in accordance with the vision and mission of the University. It focuses on addressing the needs of the students and the society through:

i) Designing and providing courses in all disciplines so far introduced in emerging areas.

ii) Emphasizing on research and innovation in emerging areas.

iv) Developing personality of the students through community engagement, sports, yoga and exercises.

The University has qualified, able and competent administrators to provide effective leadership and management at various levels. The Leadership ensures the compliance of academic and administrative processes and procedures along with the continual improvement through regular systematic audits, checks and monitoring by well-defined Quality Assurance Framework.

- The Vice-Chancellor, as the Head of the Institution steers the University in fulfillment of its vision, mission and objectives leading the students, faculties, officers and staff at all levels through developing five years Strategic Plan and setting up Broad Based Goals / Targets, responsibilities and review mechanism.
- The Registrar, as the Head of the Office governs the establishment section. He is the ex-officio secretary of the MBB University Council and Academic Council. The admission and registration process of the students of the University are managed by the Registrar. All the to and fro administrative communications are performed by the Registrar. He performs as the custodian of the records of the University.
- Controller of Examinations manages all the examinations, issuance of certificates and results. He is also in charge of monitoring the research and PhD program of the University.
- The faculty members are nominated in various administrative and academic committees of the University for Efficient Management of various functions of the University.
- University has also formed an Internal Quality Assurance Cell (IQAC) to look after various development indicators of the University. This statutory body convenes meetings quarterly every year. Various decisions for academic and cultural improvements of the students are taken in these meetings and implemented accordingly.
- Other meetings are also convened to discuss on various issues related to the academic and administrative developments of the University. Through threadbare discussions and consultations with all the members resolutions are taken unanimously and implemented accordingly.
- The activities of different academic departments are governed by Departmental Committees,

- 2. Fund from Tripura State AIDS Control Society to organize activities of Red Ribbon Club, MBB University.
- 3. Funds from external organizations such as fund from North East Council to introduce a Centre for Hindi Studies.
- 4. Funds availed from external organizations, such as DST-SERB, ICSSR, RGNIYD, Raja Rammohan National Library, ICPR, Tripura Mathematical Society, Tripura State DST, Tripura Tribal Research Center etc., to organize various academic activities like conference, seminars etc. at the University.

Being a new University, it has its limitations regarding infrastructural & financial facilities and human resources. However, these shortcomings are overcome by the dedication and integration of the employees to the University. Total man power of the University is not adequate and constant requisitions are submitted to the Government for recruitment. Various persons are in charge of more than one departments of responsibility. Both the buildings, Administrative and Academic, of the University are utilized in maximum capacity to run different academic and administrative functions. The University continuously faces fund shortage. However, the available fund is utilized optimally for the all-round development of the University and its stakeholders following the rules and regulations of Government of Tripura and the University.

#### • Contribution I: Feed Back Mechanism

Regular feed backs on teaching-learning mechanism, administrative aspects, installation and maintenance of facilities; developmental aspects etc. are collected from the students, alumni and parents. This complete process is monitored by IQAC by maintaining absolute confidentiality. After feedback collection all the collected data are analyzed by the core committee of IQAC dedicated to feedback analysis. The final report is submitted to authority and actions are taken accordingly. This feedback process is very important for optimal and efficient utilization of all the resources. This also marks the standard and requirement of up gradation in academic and administrative process.

#### • Contribution II: Conduction of Academic, Administrative, Green and Gender Audit

MBB University has introduced initiatives like Academic, Administrative, Green and Gender Audit under the supervision of IQAC. These audits are aimed to be conducted in regular intervals for all round development of the University. Core teams that are constituted to supervise and analyze these audits comprise of authority appointed IQAC members and external members from reputed institutions and organizations. This practice maintains the sanctity and transparency of the audits. Also provides a real time picture of the current scenario pointing out the areas required modification and development. Necessary actions are taken according to the recommendations of the audit report.

Along with these, IQAC contributes significantly by organizing various academic programs such as conference, seminars, awareness programs etc. IQAC also monitors the Career Advancement Scheme (CAS) for the promotion of the faculty members.

#### **Response:**

The following significant incremental improvements have been made in the time period 2016-2022 by the University:

- MBB University started with four academic programs (3 Master Degree, 1 bachelor degree) in 2016. Now in 2022 there are seven academic programs (5 Master degree, 2 integrated Master Degree, 1 bachelor degree) running successfully in the University along with two Diploma Courses.
- University constituted its First Statutes, First Ordinances and First regulations in 2018 under the Maharaja Bir Bikram University Act 2015.
- The University introduced PhD Program on 2020 along with PhD Course Work. Currently a total of 17 research scholars are pursuing PhD degree.
- University introduced publication of a peer-reviewed referred journal entitled "Adhyayan" from 2021. This journal is dedicated to publish original research articles from different fields of academia. The first issue has been published.
- University has published its News Letter from 2020.
- University has published its Annual Report in 2021.
- University organizes regular conference, seminars, workshops, awareness programs etc. involving the students, faculty members and employees for academic development and social sensitivity.
- NSS Unit of MBB University was established in 2019. Since then NSS Unit conducts various activities such as blood donation camp, cloth donation camps, awareness rallies, cleanliness drives, gender sensitization etc. for community engagement and fostering social responsibility.
- CBCS mechanism has been introduced in the University curriculum.
- University offers NSS as a 4 credit course from 2021.
- University constituted Red Ribbon Club according to the recommendations of NACO and Tripura State AIDS Control Society on 2020. Since inception this club is working to generate awareness against HIV/AIDS and Injecting Drug Use.
- University has introduced various clubs from 2020 such as Music club, Quiz Club, Drama Club, Innovation Club, Debate Club, Adventure Club, Movie Club, Eco Club, Science Club, Yoga and Meditation Center for motivating the students to pursue various extracurricular activities.
- A Coaching Centre for Competitive Examinations has been introduced in 2020 to train the students for various state and national level competitive examinations.
- University has adopted a village named "Dighalia Gram Panchayat" to foster social responsibility and community engagement in 2022. NSS volunteers regularly visit this village and participate in various social welfare activities.
- Feed Back Mechanism from students, alumni and parents has been introduced in 2018.
- CAS has been introduced in 2021 for providing career advancement opportunities to the faculty members.
- Cultural Committee of the University was formed in 2019. After that it organizes regular cultural programs involving the students of the University.

**Plan:** Conduction of Gender Audit by the appellate authority and implementation of the suggestions and recommendations of the report of this audit.

**Deployment:** Gender Audit has been conducted and implementations of the recommendations are in progress.

**Plan:** Assuring the active monitoring of the committees dedicated to look after gender sensitization in the University.

**Deployment:** Committees, such as Equal Opportunity Cells, Discipline Committee, Student Grievance Redressal Committee and Internal Complain Committee have been formed by the University so that any issues related to the gender discrimination; sexual harassment etc. is addressed stringently. These committees regularly interact with the students, both male and female, to know about their grievances, if any and take necessary actions with the permission of the authority. So far no complaints of sexual harassment or gender discrimination have been registered to the University.

Plan: Assuring the security of the female students and employees of the University.

**Deployment:** The complete University campus is under constant vigilance of the security personnel. CCTV cameras have been installed in every floor of the Academic and Administrative building so that no type of untoward incident can take place.

Plan: Assuring the maintenance and hygiene of the women's toilets.

**Deployment:** Women's toilets are available in every floor of the Academic and Administrative building. Regular maintenance is performed to provide proper cleanliness and hygiene.

**Plan:** Motivating female students to actively participate in various internal and external activities of the University by providing equal chance and opportunity.

Deployment: Faculty members always encourage each and every student, male or female, to participate

in various activities such as cultural programs, competitions, seminar, conferences, workshops, national camps etc. Female students participated in different activities spontaneously and won awards.

# 7.1.3

#### **Response:**

The University dedicates significant effort to maintain the environmental sanctity, ecological balance and biodiversity of the campus. In this regard various waste management initiatives have been adopted by the University to maintain a plastic-free, pollution-free green campus. Generation of awareness among the students against plastic pollution and environmental sensitivity is considered as the prime objective. Students are encouraged to refrain from using plastic bottles, one time plastic carry bags, plastic pet bags, cups, glasses etc. Rallies are organized in the University campus to generate mass awareness. Students along with NSS Volunteers participate in cleanliness drive, Clean India Program to maintain the cleanliness of the University campus. Management of waste is taken with utmost care. Different types of wastes are segregated and disposed properly by the cleanliness workers of the University.

- Solid Waste Management: Different types of solid wastes such as waste papers, cardboard boxes, packing materials, plastics, scrap food, scrap metals etc. are segregated and collected in colored dustbins installed in all the floors of the Academic and Administrative building of the University. In Green Dustbins different solid biodegradable wastes that are wet in nature are collected. Blue dustbins are used for non-biodegradable wastes such as plastic, scrap metals, packing materials etc. Scrap papers, glass wastes etc are dumped in Yellow dustbins.
- Liquid Waste Management: There are two main types of liquid waste are generated in the University. One is the non-hazardous and non-chemical liquid waste generated in the chemical laboratory of IMD in Chemistry course and another is the general sewage waste. General sewage

liquid is disposed off through septic tanks. Laboratory generated liquid waste is drained to the soak pits.

- E-Waste Management: Being a new University so far considerable amount of e-waste has not been generated. However, the small amount of e-waste such as broken computer parts, CDs, empty printer cartridges etc. are collected in the **Black** dustbins. Moreover, some of these are used for providing maintenance training to the office staff of the University.
- Hazardous chemicals and radioactive waste management: Hazardous chemical liquid waste, that are generated in a significantly small quantity in the IMD Chemistry laboratory are collected very carefully and disposed off according to the guidelines of Agartala Municipal Corporation (AMC) so that no environmental damage may occur.

All the dustbins are emptied regularly and are properly disposed in the dust bin maintained by AMC. Moreover, University has also installed dustbins within the campus for usage of students as well as general public to maintain the cleanliness. Students, faculty members and employees are encouraged to dispose off the wastes in the appropriate dustbins so that waste management can be manitained effectively and efficiently.

Title of the Practice: Swachhta Hi Seva: A Green Initiative

#### A. Objectives of the Practice:

- 1. To create an environment friendly campus.
- 2. To generate awareness about environmental sensitivity among the students and local communities.
- 3. To maintain the hygiene of the students in the campus.
- 4. To make the campus plastic free.
- 5. To make the campus tobacco free.
- 6. To plant as many new tree saplings as possible within the campus.
- 7. To maintain biodiversity and ecological balance in the university campus.

8. To beautify the university campus through green measures.

#### **B.** The Context:

- 1. The ground water level in the MBB University campus is going down day by day, especially during the dry season. This poses a serious problem to the availability of water in the university campus.
- 2. MBB University is situated at College Tilla. A popular destination for evening & morning walk and sports activities. However, due to lack of awareness, many pedestrians throw plastic litters here and there in College Tilla. This creates a severe threat of plastic pollution and to the drainage system.
- 3. Tripura has been experiencing negative impacts of climate change, such as prolonged summer, delayed rainy season and winter etc. over the last decade. This impacts the socioeconomic life of the people of Tripura.
- 4. Rapid urbanization and deforestation in Tripura is a major cause of environmental concern.
- 5. Sustainable development and attainment of its goals is the need of the hour.

#### **C. The Practice:**

- Instead of plastic covered flower bouquets, university has adopted the practice of felicitating the dignitaries with tree saplings.
- The University campus has been declared plastic free and tobacco free.
- Plantation of trees during various programs such as Van Mahotsav, World Environment Day, World Earth Day etc.
- Awareness Rally to generate mass awareness among the people against pollution especially plastic pollution.
- Environmental awareness programmes organized by the University through the NSS Unit, Red Ribbon Club, Eco Club in the Adopted Village.
- All the electrical lights of the University have been upgraded to energy saving LED lights.

#### **D. Evidence of Success:**

- 1. The University declared the University campus as plastic free zone. The employees and the students of the University are aware to maintain the campus as plastic free campus. They dispose of the waste items in the designated place, bins maintained in different corners of the University campus.
- 2. The University is a tobacco free campus. The administration maintains a provision of imposing fine for violating the rule on the use of tobacco. Till now there is no any evidence of violating this rule.
- 3. Use of tree sapling as means of felicitation during programmes by replacing the common practice of felicitation with flower bouquet.
- 4. The University has succeeded to motivate students towards active participation in different environmental programmes within and outside the University that are organized by the University.
- 5.Gardens with trees and flowers have been developed and maintained properly for green beautification of the campus.
- 6.MBB University conducted an All-round Development Door-to-Door Survey at the Dighalia Gram Panchayat, the Adopted Village of MBB University during March 12, 2022 to May 02,

2022. Various environmental issues were addressed in this survey and the report was submitted to Government of Tripura.

7.3.1

Portray the performance of the Institution in one area distinctive to its priority and thrust within 1000 words

#### **Response:**

MBB University considers "Fostering Social Responsibility and Community Engagement" as one area distinctive to its priority and thrust.

- Village Adoption: The University has adopted a village named "Dighalia Gram Panchayat" in Bamutia RD Block, West Tripura for fostering social responsibility and community engagement. The NSS Volunteers have completed a Wellness and Development Survey among the 2307 villagers of this village to interpret current development scenario. Along with that the NSS volunteers and NSS Programme Officer regularly visit and serve in this village to generate social awareness, to conduct cleanliness drives and community development programs.
- Awareness Generation against HIV/AIDS and Injecting Drug Use: The whole North East region of India as well as Tripura suffers from high HIV/AIDS prevalence. The more alarming is that in the past few years the addiction to the Injecting Drug Use has become the prime causative agent of HIV/AIDS among young students of schools, colleges and universities. In this context, University has formed the Red Ribbon Club according to the recommendations of NACO and Tripura State AIDS Control Society.

- Helping the Helpless: the University follows the ideology of Swami Vivekananda who said to serve the others is to worship the God. The University, therefore, extends its hands to the helpless and needy people.
- Awareness about Gender Sensitivity: To aware the students about gender sensitivity is the need of the hour as the cases of gender violence and intolerance are increasing every day. The University organizes various activities and awareness programmes to sensitize the students on gender issues.
- **Prevention of Depression among the students:** According to WHO within 2030 the Mental Depression will become a worldwide pandemic. Therefore, the development of mental health is essentially required for all round development of the students. The University organizes various programs and activities to prevent the students from mental depression. The same is also extended to the Adopted Village of MBB University for fostering social responsibility and community engagement.
