#### (1) EVALUATION OF QUOTATIONS:

- (a) The quotations received by the MBB University and those meeting the criteria, will be considered. After opening of the quotations in presence of the representative of the CA Firms who remain present on the date and time of opening of quotations at MBB University, a list will be prepared for qualified. Firms by the TC (*Tender Committee*) of MBB University and a comparative statement will be prepared by the TC for evaluation of the financial bids. The financial bids of the unqualified bidders will not be considered for final evaluation.
- (b) If two or more bidder quote same rates, then experience of Firm (Old date of constitution of Firm) as mentioned in the ICAI (Institute of Chartered Accountants of India) Registration Certificate to be considered.

#### (2) TERMS AND CONDITIONS:

- (i) The CA (Chartered Accountant) Firm must have registered office at Agartala, West Tripura and all the communication to the Firm will be made to that office address only.
- (ii) Registered with the Income Tax Permanent Account Number (PAN) & GST Registration Number, ICAI (Institute of Chartered Accountants of India) and the Firm should be empanelled with Comptroller and Auditor General of India (C&AG) and valid copies of the documents should be submitted.
- (iii) Have at least 3 (Three) years of experience in compilation of annual accounts at any Central or State level Govt. Institutions/Govt. Departments/Autonomous Bodies/PSUs/ Universities/Colleges etc. Copies of the latest work orders/award letters received from any Government Departments/ Autonomous Bodies/PSUs/Universities/ Colleges etc. have to be submitted along with the bid.
- (iv) Not have been blacklisted by any Govt. or any other Organization. Authorized signatory of the Firm to submit an undertaking to this effect.
- (v) The compilation of annual accounts of Maharaja Bir Bikram University shall be carried out in the office at Administrative Building of the Maharaja Bir Bikram University, Agartala, Tripura (W).
- (vi) Quotation should be accompanied with Cost of quotation papers (Non-refundable) of Rs 500/- (Rupees Five hundred) only and EMD (Earnest Money Deposit) of Rs 1,000/- (Rupees One thousand) only in the shape of Demand Drafts (DD) issued by any Nationalized Bank in favour of "DDO, Maharaja Bir Bikram University" payable at Agartala. Quotation without Cost of quotation papers & EMD fee will be summarily rejected.
- (vii) The EMD (Earnest Money Deposit) of the bidders will be refunded without any juterest after issuing of the award letter.

- (viii) Quotations received after the last date and time stipulated in the notice are liable for rejection.
- (ix) Date & time of opening of the quotation is July 14, 2025, 11.00 AM at Administrative Building of MBB University, if possible. The interested bidders or their authorized representatives are requested to remain present at the time of opening of the Bid(s).
- (x) The price quoted by the CA Firm should be valid for the entire contract period and payment will be made on agreed rate. No price variation would be allowed during the entire contract period. Please note that rate should not be less than Rs 7,000/- (Rupees seven thousand) excluding taxes for compilation of annual accounts of Maharaja Bir Bikram University.
- (xi) The selected Firm will conduct compilation of annual accounts of MBB University for one Financial Year 2025-26 which may be renewed for another 02 (two) Financial years (FY 2026-27 & 2027-28) on satisfactory completion of the assigned work(s). MBB University, reserves the right to discontinue the service(s) of the Chartered Accountant Firm at any time during the period by serving one week notice.
- (xii) Submit offers as per given Annexure-A & B. Any alteration is made in the given forms will be treated as incomplete offer and is liable to be rejected.
- (xiii) The selected CA Firm should submit the compilation report for the financial year (s) within 10 (ten) working days from the date of assignment.
- (xiv) The CA Firm shall be given access to all information relevant for the purpose of conducting the compilation of annual accounts of MBB University. This would normally include books of accounts, all documents, correspondence and other information associated with MBB University during the Financial Year(s).
- (xv) TDS will be deducted as per income tax act/rules. GST will be paid at prescribed rates.
- (xvi) Disagreement if any, arising out of the EOI/contract shall be settled by either party in a court of law under the jurisdiction of the High Court of Tripura only.
- (xvii) The authority reserves the right to accept or reject any or all the offers received or cancel the process at any stage prior to award of contract and without assigning any reason thereof.
