Ph.D. ADMISSION NOTICE: ACADEMIC SESSION 2024-25

Maharaja Bir Bikram University, Agartala invites applications for admission to Ph.D. programme in Library & Information Science and Political Science for the academic session 2024-2025. The prescribed application format is available in the MBB University Website (https://mbbuniversity.ac.in/) and the applicants are required to submit the duly filled up form along with all the necessary documents and receipt of the deposited requisite fees within March 03, 2025 (04.00 PM). The applicants may submit the filled up application form along with depositing of the requisite fees during February 05, 2025 (10.00 AM) to March 03, 2025 (04.00 PM) (except holidays). Department wise available seats are given below:

- Eligibility Criteria: As per Maharaja Bir Bikram University Ph. D. Regulations-2020 available in the link: https://mbbuniversity.ac.in/sites/default/files/2024-06/First-Amendment-of-MBBU-First-Regulations-2018.pdf
- **Display of Lists of eligible candidates:** The list of candidates eligible to appear in RET-2024/ Interview shall be displayed in the MBB University website. It is to be noted that Qualifying in RET does not entitle a candidate to get admission into the Ph.D. program.
- The intake capacity of the Supervisors and Departments is as per Maharaja Bir Bikram University Ph.D. Regulations 2020. However, mere possession of 'Eligibility Criteria' does not entitle right to anyone to get admission to any programme under Maharaja Bir Bikram University. Regarding selection of Eligible Candidates for admission to any Ph.D. Programme, decision of the Admission Committee shall be final.

Admission Process of Ph.D. programme:

1. The University shall allow a candidate to get admission to the Ph.D. Program when he/she qualifies in RET (Research Eligibility Test) conducted by the MBB University. Appearing and Qualifying in the RET is mandatory for getting admission to Ph.D. Programme of MBB University.

2. There are two parts of RET.

A. Written Test: 100 Marks

B. Viva-Voce: 100 Marks

- 3. The Written Test will be of 100 marks with three (3) hours duration. Syllabus, Question Structure of the Written Test for different Subjects are available in ANNEXURE-I & II.
- 4. The medium of RET shall be English for programmes other than language subjects.
- 5. The RET will be conducted at Maharaja Bir Bikram University, College Tilla, Agartala, Tripura, Pin-799004. No TA/DA shall be provided by the University for appearing in the RET.
- 6. To be eligible to appear in the Viva-Voce one has to secure 50% out of 100 marks in the Written Test (45% for SC/ST/ Differently-Abled Applicants).
- 7. The Candidates who have an M. Phil (of two-year full time regular course), or in case of the candidates who have qualified in the UGC NET/CSIR-NET/SET/SLET/GATE/GPAT/Teacher Fellow/Scientist or any other examination that may be deemed equivalent by the Departmental Research Committee (DRC), do not require to appear in the Written Test. They are directly eligible to appear in the viva-voce.
- 8. Course Work completed from any UGC listed University will be transferable to this University and they will directly be admitted in the Ph.D. Program after clearing the Viva-Voce exams from the Department concerned. If any candidate has completed the Course Work as per UGC norms in any University he/she will be eligible to get admitted in Ph.D. programme of MBB University. His/her Course Work credit will be transferred as per UGC norms. Such candidate will be exempted from coursework for Ph.D. programme.
- 9. The candidates qualified in the written test being a part of the RET and others who are exempted from appearing at the written test will be treated as candidates to appear in the Viva-Voce examination of 100 marks in the concerned Department.
- 10. The Viva-Voce shall also consider the following aspects, viz. whether:
 - a) The candidates possess the competence for the proposed research.
 - b) The research work can be suitably undertaken at the institute.
 - c) The proposed area of research can contribute to new/additional knowledge
- 11. The candidates for Ph.D. programme will be finally selected on the basis of merit position secured in the Viva-Voce and number of seats available in the Department.
- 12. A foreign national who is a recipient of fellowship for Ph.D. by a foreign institution or an Indian citizen in the receipt of Ph.D. fellowship from Indian Council for Cultural Relations (ICCR) or any other organization or institution recognized by the Government of India and who is sponsored by his /her Government or similar Government agencies shall not be required to appear at the Ph.D. Entrance test or RET or the case may be.

- 13. List of eligible candidates for RET examination, schedule of the test and rules & regulations related to the RET will be available in the university website (https://mbbuniversity.ac.in/) in due course. Candidates are requested to remain updated for the same through the university website. The university will not be responsible if a candidate fails to adhere to any information related to ret and admission.
- 14. How to apply: The applicants are required to download the prescribed application form. After filling up the prescribed application form, applicants have to submit the application form along with the documents as mentioned below including the receipt /proof copy of depositing the requisite application fee to the Administrative Block MBBU. The requisite Application Fee of Rs. 1000/- (for General Candidates) and Rs. 700/- (for SC/ST/PWD Candidates) is to be deposited by the candidates in the following Bank Account on or before March 03, 2025 by 04:00 PM.

Question Pattern for Admission Test:

- a) Questions shall be prepared into two separate groups, "Group-A" and "Group-B".
- b) Group-A will carry questions related to "Research Methodology" and Group-B will carry questions related to "Library and Information Science".

- c) Further, each group will contain questions of 50 marks each.
- d) There shall be total ten essay type questions. Each group will carry five questions carrying 10 marks each with choice basis of one extra question for each section. Thus, candidates shall have to answer any five questions out of six questions from each group.

General Guidelines

A. Written Test:

- 1. There shall be a Written Test of 100 Marks.
- 2. Duration of Written Test shall be 3 hours.
- 3. The Written Test shall be conducted in two Groups [Group-A (50 Marks), Group-B (50 Marks)]. Separate Answer Scripts shall be used for Group-A and Group-B.
- 4. In case of **Group-A**, candidates are required to attempt two (2) out of four (4) questions each carrying 25 Marks (25x2=50). For **Group-B**, candidates are required to attempt two (2) out of four (4) questions each carrying 25 Marks (25x2=50).
- 5. **Qualifying Marks** in the Written Test for General Category is 50% and for those of Reserved Category Candidates is 45% to be eligible to appear in the Interview.
- **B.** The entire Admission process as well as Course Work shall be in English Medium only.
- C. If selected, students shall have to attend at least 75% of the total classes conducted in the entire Course Work, failing which no candidate shall be allowed to appear in the Course Work Final Examination.
- **D.** Every enrolled student must also have to participate in Seminars/Group Discussions and other Academic Activities to be organised by the Department during the entire Ph. D Programme.
